Impact of private military security contractors and foreign military bases on global security

The agenda delves into the complex roles of private military contractors (PMCs) and foreign military bases in modern conflicts. PMCs, often operating with limited oversight, can blur the lines between state objectives and corporate interests, potentially compromising national sovereignty and escalating violence in conflict zones. Their involvement raises ethical and legal concerns, especially when lacking accountability mechanisms. Similarly, foreign military bases, while sometimes enhancing security, can undermine the host nation's sovereignty and fuel regional tensions. These bases may also support authoritarian regimes, complicating efforts toward democratic governance. The agenda encourages critical analysis of these non-state actors, focusing on their implications for sovereignty, human rights, and regional stability. Students will explore contemporary security challenges, including the difficulties of regulating and holding accountable entities that operate beyond traditional warfare frameworks.

Combating the rise of state-sponsored cyber attacks on governmental infrastructure

The agenda focuses on the escalating threat posed by state-sponsored cyber attacks targeting critical governmental infrastructure worldwide. It aims to address the urgent need for enhanced cooperation, the development of robust legal frameworks and strengthening of national cyber security frameworks, effective mechanisms for attribution, deterrence and response to these malicious cyber activities. The agenda focuses on combating cyber crime and transnational organized crime.

The Economic and Financial Committee is the Second Committee of the United Nations General Assembly. It focuses on global economic issues, including international trade, financial systems, economic development, and efforts to reduce poverty. ECOFIN allows students to explore the economic impact of global challenges, debate fiscal policies, and propose solutions for sustainable growth. It helps delegates understand the link between economics and global stability.

Ensuring Fair Trade Practices in Global Supply Chains.

The agenda is centered around establishing fair practices for global supply chains, environmental sustainability, encompassing labour rights, ensuring consumer rights and equitable application of tariffs and taxes across international trade. The agenda aims to address issues regarding trade imbalances caused by tax regimes, while also focusing on minimizing labour exploitation in weaker nations ensuring a globalized economy. The agenda addresses current issues in the global trading system such as, trade wars, carbon emissions, worker exploitation and labour rights, while also bringing scrutiny and consumer awareness.

The Social, Humanitarian and Cultural Committee (SOCHUM) focuses on a broad spectrum of issues related to human rights, social development, and cultural affairs. SOCHUM deals with a wide spectrum of issues ranging from social justice, humanitarian crises and cultural tolerance.

Addressing the Global Rise of Digital Authoritarianism and Protecting Human Rights in the Age of Surveillance

The agenda focuses on the growing threat of digital authoritarianism, and its implications on human rights. In the age of surveillance, the surveillance itself turns into a topic up for debate, whereas such authoritarianism is used to suppress dissent, monitor citizens and manipulate information, which leads to exploitation of the human right to privacy and expression, it also renders importance in aspects of national security and counter terrorism, and prevention of crime and law enforcement. The agenda deliberates the impact of such mass surveillance on freedom of speech, privacy and press freedom, the responsibilities of tech companies, platforms and states in upholding digital human rights and the legal frameworks to safeguard digital freedoms.

The World Health Organisation (WHO) is a specialised agency of the United Nations responsible for international public health. It has addressed pandemics (COVID-19, H1N1, Ebola), vaccination campaigns (polio eradication), and universal health coverage. It is crucial in coordinating international responses to health emergencies and promoting universal health coverage, disease prevention, and health equity worldwide.

AGENDA

Addressing mental health issues with emphasis on support and intervention for adolescents.

This agenda focuses on the growing global concern surrounding adolescent mental wellbeing. Emotional and psychological challenges among youth are increasing and often remain unrecognized due to stigma, low awareness, and limited access to care. The agenda addresses the rising prevalence of mental health issues and the barriers to support services. It emphasizes acknowledging these concerns, identifying socio-environmental and digital factors impacting adolescent wellbeing, and exploring strategies for early intervention and support. It also discusses integrating mental health support into broader healthcare and education systems to ensure accessibility, inclusivity, and cultural sensitivity, while bridging the gap between policy and practice. As of 2025, mental health is a key part of public health, especially as the post-pandemic generation faces academic disruptions, social uncertainty, and digital overload.

The committee offers a platform for students to debate pressing domestic issues like national security, education, or economic reforms from diverse political perspectives. AIPPM encourages awareness of Indian politics, enhances public speaking and negotiation skills, and helps students understand the complexities of democratic decision-making and multi-party governance.

Assessing the implementation of National Education Policy with special emphasis on curriculum reforms and representation of Indian heritage.

The agenda revolves around critically examining the implementation of this policy, particularly the reforms related to the curriculum and its structure, and the promotion of Indian education systems, arts, languages and cultural heritage in school and college syllabi. However, debates around the representation of Indian heritage in the textbooks have arisen, especially with the recent changes in the NCERT syllabus. Concerns have been raised regarding the selective inclusion of historical figures and cultural narratives, such as the promotion of certain dynasties or rulers over others, that led to allegations of ideological bias or historical erasure. These controversies make it vital to ensure that curriculum reforms remain inclusive, balanced, and academically grounded.
